 - Experienced Evaluators

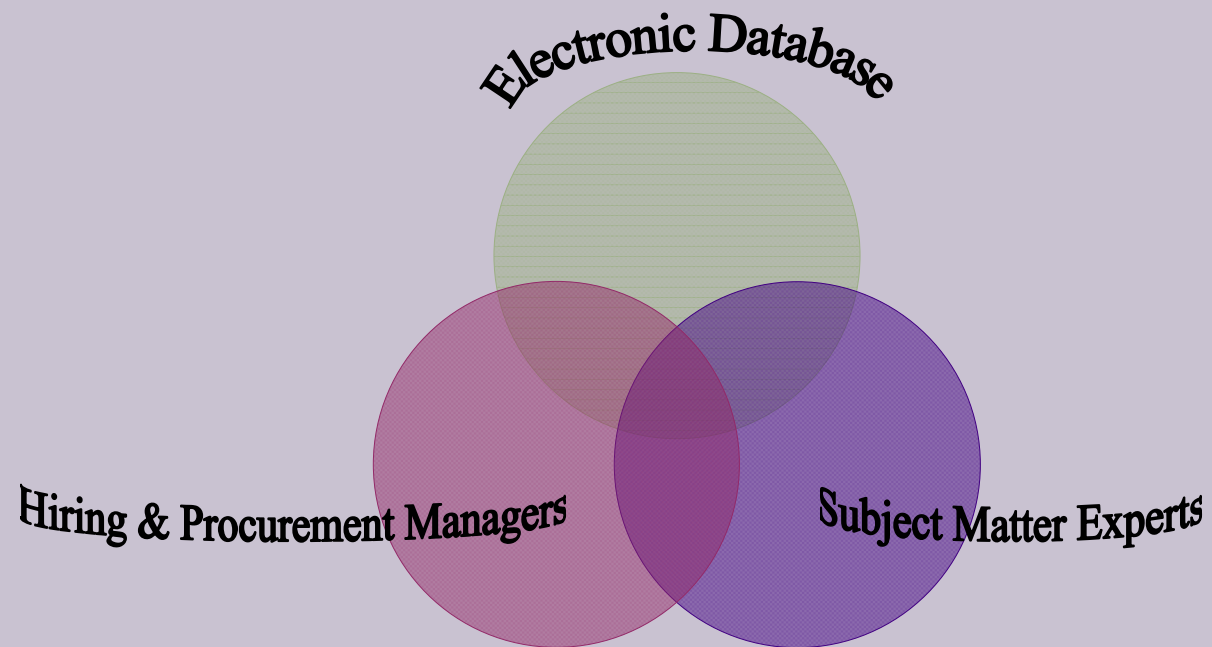
What is ESN?
